**Waiver of Liability, Release, Assumption of Risk and Indemnifying Agreement:**

For and in consideration of participant's registration with USA Hockey Inc. it's Affiliate, Local association and member team (hereafter USAH) and being allowed to participate in USAH events and member team activities, the parent(s) or legal guardian(s) of participants relinquish any and all liability for and cause of action for personal injury, property damage, or wrongful death occurring to participant arising out of participation in USAH events or member team activities or the sport of ice hockey, or and activities incidental thereto, wherever or however they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant may have are hereby relinquished and the participant parent(s)/ guardian(s) does (do) so on behalf of my/our participant's heirs, executors, administrators, and assigns.

Participant and/ or participant's parent(s)/guardian(s) acknowledge, understand, and assume all risks inherent in ice hockey and any member team activities, and understand that said sport and activities involve risks to participant's person including bodily injury, partial or total disability, paralysis, and death, and damages which may arise there from and that I/we have full knowledge of said risks. These risks and dangers may be caused by the negligence of the participant or the negligence of others, including the "releases" identified below. It is further acknowledged that there may be risks and dangers not known to use or are not reasonably foreseeable at this time.

Participant and /or participant's parent(s)/ guardian(s) acknowledge, understand and assume all risks, if any, arising from the conditions and use of ice hockey rinks and related premises and acknowledges and understands that included within the scope of this waiver and release is any cause of action, arising from the performance, or failure to perform maintenance, inspection, supervision, or control of said areas and for the failure to warn of dangerous conditions existing at said rinks, for negligent selection of certain releasees, or negligent supervision or instruction by releasees. It is the purpose of this agreement to exempt, waive, and relieve releasees from liability for personal injury, property damage, and wrongful death caused by negligence, if any, of releasees. Releasees include USA Hockey Inc., its Affiliate Associations, Member teams, Events Hosts, other participants, coaches, officials, sponsors, advertisers, owners and operators of the premises used to conduct any event and each of them, their officers, directors, agents, and employees.

Participant or participant's parent(s)/guardian(s) agree if any claim for participant's personal injury or wrongful death is commended against releasees, he/she shall defend, indemnify, and save harmless releasees from any and all claims or causes of action by whomever or wherever made or presented for participant's personal injuries, property damage, or wrongful death.

Participant and/or participant's parent(s)/guardian(s) acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representations of releases, that they are fully advised of the potential dangers of ice hockey and understand these waivers and releases are necessary to allow amateur ice hockey to exist in its present form.
